Kane Ranch Open House

The Grand Canyon Trust is hosting an open house at the Kane Ranch to celebrate the restoration of the historic Kane Ranch House and its listing on the National Register of Historic Places. In 2005, The Grand Canyon Trust and Conservation International purchased the Kane Ranch and Two Mile Ranch grazing allotments and began practicing conservation-based land management on 850,000 acres north of the Grand Canyon. Their interdisciplinary approach includes preserving the culture history of the area. One of their first efforts was to restore the historic Kane Ranch House, built around 1877. Over the past few years the building has been substantially restored by a crew led by GCHS's own John Azar.

Grand Canyon Historical Society Board Meeting Minutes Saturday, November 1, 2008 East Flagstaff Public Library Meeting Room

Meeting was called to order at 9:15 am. Present were officers - President Keith Green, Vice-President/Outings Coordinator Erik Berg, Treasurer Susan Billingsley and Secretary Nancy Green. Also present were board members Paul Schnurr, George Billingsley, Lee Albertson, Amy Horn and Bev Loomis. Newly elected board members who were not present, but accounted for because of previous engagements were Jackie Brown, John Azar and Kirstin Heins. Adair Peterson was also elected to the board. Heartfelt thanks and congratulations are extended to these five new board members for being willing to serve the Society.

Minutes from the last meeting on February 9 were read by Nancy Green. Susan made a motion to approve the minutes, Paul seconded the motion. Motion carried.

Susan presented the treasurer's report. Fred Swanson was given a free year's membership to the Society to thank him for his book sales donation. Amy made a motion to approve the treasurer's report. Erik seconded the motion. Motion carried.

Keith gave a State of the Society and Grand Canyon National Park news update. The Hermit Road Project is almost completed. It was much needed, as the last time realignment was done was in the 1960's. It had degenerated badly due to the shuttle buses – something the road had never been designed for. In addition to the new road, there will also be new pedestrian walkways. The Grand Canyon Recreation Center is sponsoring a marathon as a community fundraiser. It will occur on November 15. Superintendent Steve Martin has worked on alleviating the parking problem. 600 new parking spaces are being created around CVIP. The road between CVIP and Mather Point will eventually be closed and used as a pedestrian walkway. Trial shuttle bus runs this summer between Tusayan and the park, and the Village and Desert View appeared to be successful. The new entrance and parking at Desert View

are completed. Efforts to increase visitor use of the Desert View entry to the park are being made by ADOT signage and park advertisements. Only 2% of Grand Canyon visitors use the Desert View entrance. Verkamp's has been taken over by NPS and GCA. It will be used by the Interpretive division and as a GCA bookstore. The question was raised if our Society could also utilize this building for meetings and/or a place to stage outings. Could this be a place to disseminate brochures? House a display case? Give fireside chats? Keith will find out about this for us.

This year the Society had some great outings. Thanks so much to Erik Berg for stepping up in the absence of Henry Karpinski to facilitate so many fine events. Erik planned the Grand Canyon Airport at Red Butte/Planes of Fame Museum tour in Valle. Erik was the one who got our Shoshone Point picnic permit for us. He also stepped in to cover the outing to Page when Richard Quartaroli became involved with the Katie Lee exhibit. Other fine events were the Ruth Stephens Baker memorial at Kolb Studio; and author Fred Swanson's discussion of his new book about Dave Rust paired with a historic boats tour by Jan Balsom. Thanks to all who helped to plan and pull off these interesting outings.

Membership – Concerns were raised over the slightly dropping numbers. We used to have over 200 members. There now are 185. Not only do we need members, we need ACTIVE members. It used to be that 200 addresses were necessary for our mailing permit. The Society will be making moves in 2009 to utilize email for our postings. Email addresses must be included on new or renewing membership forms. The Bulletin will be delivered via email. However, if you want to receive paper copies of the publications, that is certainly still an option. All you have to do is request this. Reminder emails could be sent out prior to an event. This change is necessary in the digital age – but it also will help to save a tree and save postage.

Al Richmond will continue with the three aspects of Society business that we have been so fortunate he is willing to do for us. Al is the chairperson for the Scholarship committee. This year, for the first time, the information will also be disseminated to U of A and ASU as well as NAU. Al is also the chairperson of the Hall of Fame award, and will continue to do so. He also has been our statutory agent for the Arizona Corporation Commission to file our non-profit status. He will continue to do this as well. Thank you so much Al for all your hard work.

The election of officers took place. Here is your new slate of officers for 2009. Thank you and congratulations!

President – Erik Berg Vice-President/Outings Coordinator – John Azar Treasurer – Paul Schnur [later stepped down, Keith Green is now treasurer]

Discussion took place concerning our publications. The opinion was that we published too few editions of the Bulletin and the Ol' Pioneer in 2008. For 2009, the proposal is three editions of the Ol' Pioneer and six editions of the Bulletin. These will be transmitted electronically for the most part. Amy will write an article explaining the changing policy for mailings as of March, 2009. Erik will communicate with Mary Williams, editor of the Ol' Pioneer and Karen Greig, editor of the Bulletin about these changes. Mary is already paid for her work. Lee made a motion to pay both Karen and Diane Cassidy, webmaster, \$150.00 for their services. Bev seconded. Motion carried.

John Azar gave us an email update of the work on the Pasture Wash Ranger Station. This July, John, along with Grand Canyon Youth led by Jacob Fillion, Tom and Wes Myers, and the Supai gatekeepers worked on the station for a week. The last ranger to work at the station in 1978 came and gave a talk and a tour. There are plans for another week of work next July. If so, the Society would like to be a part of that for an outing as well as helping with the work.

Discussion was held concerning the Pioneer Award. Susan made a motion that the award continue to be for one person per year, in order to keep it special and meaningful. Bev seconded. The motion carried. George had previously been the chairperson, but asked to have someone else take this over. Kirstin was nominated in absentia as the chairperson. Amy, Keith, Erik and Nancy will also serve on this committee. Nominations need to be received by March 15 so that the plaque can be made by the Department of Corrections. Lee said he would help see that happen. Keith will obtain the permit necessary for the Shoshone Point picnic in June. This is when the Pioneer Award will be presented. It was also proposed that this is when the scholarship recipient could make a presentation.

A proposed and tentative outline of outing events was formulated. Here is what we have so far, and is by no means the final schedule.

March – Amy Horn will see if the Society could participate along with the (River) Guides Training Seminar at Marble Canyon. The Society could operate a table to explain about our historical mission and quite possibly garner new members. Erik could do his presentation of the 1937 Cal Tech/Carnegie expedition.
